Three Steps to Becoming a Sustaining Member Company

Step 1: Determine which employees should be involved with ULI and select a member type for each one. The employees can be in a single office or multiple offices worldwide. The total should add up to \$10,000 or more.

Step 2: Select an employee to serve as the group coordinator.

▷ This person does not need to be counted as a member. He or she will work with the ULI Account Manager to ensure that your membership roster is up to date and correct and to help facilitate distribution of benefits, such as who will receive the free Fall Meeting and Spring Council Forum registrations.

Step 3: Ask your group coordinator to contact ULI's Sustaining Membership Representative to discuss details.
